Termovalorizzatore o discarica? Economia circolare o discarica sostenibile? Si può continuare veramente a porsi di fronte a scelte da fede calcistica, spesso dettate da ignoranza totale di quanto si osteggia o non è il momento di documentarsi attraverso un approccio scientifico, chiaro e completo?

La conferenza internazionale **“What do you really know about waste and health: the risks of the NIMBY Syndrome”** ci porterà dentro al vastissimo tema del rapporto tra rifiuti e salute, un campo minato nel quale il rischio saltare in aria su una fake news è altissimo con conseguenze letali per la comprensione della realtà dei fatti e la libertà di scelta consapevole.

L'incontro è ideato dal **Comitato Scientifico di Catania 2030**, in partnership con **l'Università Politecnica di Atene**, **l'Università di Catania**, **il Comitato Interdisciplinare Rifiuti e Salute (CIRS)** e **l'Associazione nazionale di Ingegneria per l'Ambiente e il Territorio (AIAT)**.

I relatori internazionali ci condurranno nel confronto tra le diverse alternative di gestione dei rifiuti prendendo esempio dalle migliori esperienze di gestione a livello mondiale. Attraverso una riuscita fusione tra il mondo dei tecnici, dei gestori di impianti, dei ricercatori e il mondo della medicina - quella vera - si comprenderà quanto delle paure più diffuse è realmente fondato, quanto è strumentale e quali rischi effettivi quelle stesse paure paradossalmente comportano portando sempre più spesso e sempre più imprudentemente a rifiutare impianti necessari e sicuri

Waste-to-energy plant or landfill? Circular economy or sustainable landfill? Can we really continue to face rigid and hypocritically alternative choices of “football faith”, often dictated by total ignorance? or it is not the time to get a clear knowledge of the different but complementary options and related issues through a scientific, robust and holistic approach?

The international conference **“What do you really know about waste and health: the risks of the NIMBY Syndrome”** will bring us into the broad but still little explored issue of the relationship between waste and health, a minefield in which the risk of blowing up on fake news is very high with lethal consequences for understanding the reality of the facts and freedom of conscious (political) choice.

The Conference is organized by the **Scientific Committee of Catania 2030**, in partnership with the **Technical University of Athens**, the **University of Catania**, the **Italian Interdisciplinary Committee on Waste and Health (CIRS)** and the **Italian Association of Engineer for Environment and Territory (AIAT)**. Prestigious international

speakers will lead us through a comparison between the different waste management alternatives showing the best management experiences in the world. Through a successful fusion between the world of technicians, plant operators, researchers and the world of medicine we will understand how much of the most widespread fears is really founded, how instrumental are some fake news and what real risks, those same fears, paradoxically entail leading more and more often and recklessly to refuse necessary and safe plants on our territories.
